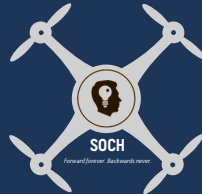

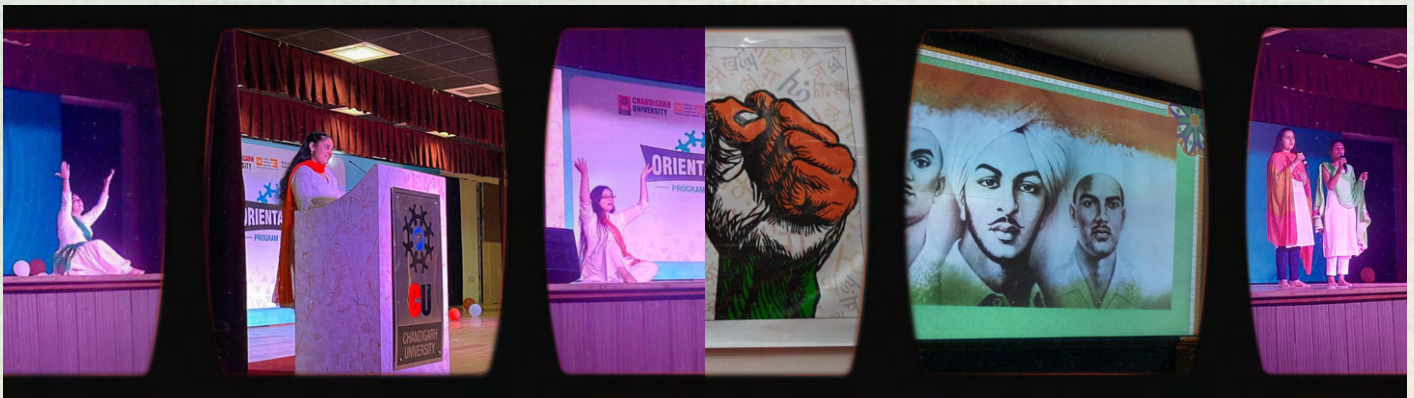

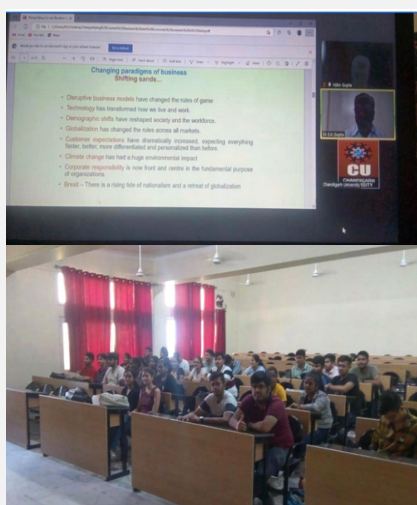
# DEBATE COMPETITION

## NUKKAD NATAK & ELOCUTION COMPETITION

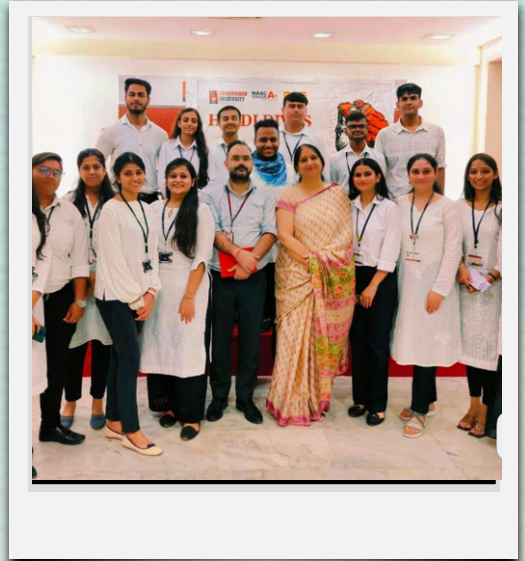

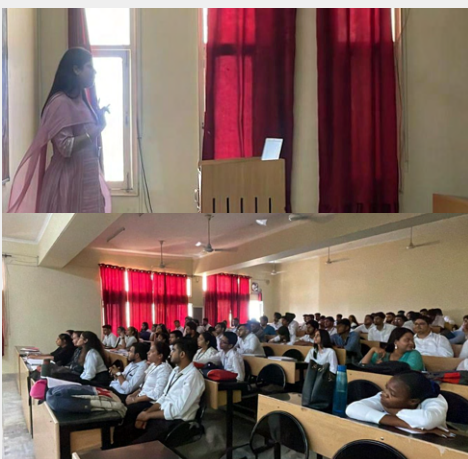


# HINDI DIWAS

# INTERNATIONAL UPDATES

---

## INTERNATIONAL CRIMINAL COURT

### Issuance of Arrest Warrants for Vladimir Putin, the President of Russia

- The international criminal court issued Arrest Warrant against Vladimir Putin, for a destructive invasion of Ukraine's territory, on 17 March 2023.
- Around 123 nations across the world agreed to the detention of Putin and Lvova-Belova in case they come to their respective territories.
- Vladimir Putin, the first leader of a permanent member of the UN Security Council on whom an Arrest warrant is issued
- Ukrainian-crises is renamed as Russo-Ukrainian War.

## INTERNATIONAL COURT OF JUSTICE

### Surprising Decision by International Court of Justice in Silala river dispute case (Chile v. Bolivia) –

- ICJ delivered the Judgment over the legal status & use of waters of the Silala River saying as "parties agree with respect to the legal status of the Silala River", the court declared that there was no need for the judges to pronounce a decision on the matter."
- This decision put into a surprising moment for both Parties while delivering judgment on, 1st December 2022
- Case title - Dispute over the Status and Use of the Waters of the Silala (Chile v. Bolivia)

### Violations of Sovereign Rights and Maritime Spaces in Nicaragua's EEZ (Nicaragua v. Colombia)

- International Court of Justice delivered a Judgement on 21 April 2022 stating the wrongful and unlawful act done by Columbia.
- "Colombia had violated Nicaragua's sovereign rights and jurisdiction in the latter's exclusive economic zone," said ICJ judges.

## UNITED KINGDOM

---

### RESIGNATION OF PRIME MINISTER LIZ TRUSS –

- Resignation of Prime Minister Liz Truss just after 45 days of appointment as Prime Minister
- Tenure of Liz Truss being Prime Minister 5 September 2022 – 24 October 2022. The official message "I have therefore spoken to His Majesty The King to notify him that I am resigning as Leader of the Conservative Party." Prime minister leadership of Liz Truss is Preceded by Boris Johnson and succeeded by Rishi Sunak on 24th October 2022.
- First time in the record of 300 years of Britain for shortest serving Prime Minister



# UNITED STATES

---

## US SC OVERTURNED ROE VS WADE

- The United States Supreme Court on Friday (June 24) overturned by a 6-3 majority 'Roe v. Wade', the court's landmark 1973 judgment that made abortion a constitutional right.
- The three liberal justices dissented, saying the majority opinion "says that from the very moment of fertilization, a woman has no rights to speak of", and that conservatives well knew states would enact – and in many cases had already enacted – abortion restrictions to the moment of conception.
- Under state restrictions, "a woman will have to bear her rapist's child or a young girl her father's – no matter if doing so will destroy her life", the liberal justices wrote.
- The US is one of only four countries since 1994 to restrict abortion, according to the Center for Reproductive Rights, the others being Poland, Nicaragua and El Salvador. This will further set America apart from peer countries as life expectancy falls. It could also damage efforts to advocate for the rights of women and girls globally.

## TECHNOLOGY

---

### ChatGPT under microscope in many countries

- The data protection authority in Italy recently banned ChatGPT, the viral AI chatbot from OpenAI citing privacy concerns. The Italian Data Protection Watchdog - Garante ordered OpenAI to stop processing Italian users' data during an investigation into a data breach that allowed users to see others' chatbot conversation titles.
- The European Union body that unifies national watchdogs on Thursday said that it had set up a task force on ChatGPT, OpenAI's viral conversational AI tool that was recently banned in Italy over privacy concerns.
- Apple will soon allow alternative app stores on its devices. The move is part of Apple's sweeping overhaul aimed at complying with strict European Union requirements that will be implemented in 2024.
- The Competition Commission of India ruled in October that Google exploited its dominant position in Android and told it to remove restrictions on device makers.
- Google soon to cooperate with India's competition authority after the country's top court upheld an antitrust order forcing the U.S. firm to change how it markets its popular Android platform.



# LEGAL UPDATES

On 29 September 2022, the Department of B.Com, LL.B(H) at UIIS organised a JAM- JUST-A-MINUTE competition on the occasion of World Health Day. The competition took place in the moot courtroom from 3:30-4:30 PM and was supervised by Avneet Minhas, as Faculty Coordinator and Palak Sharma as Student Coordinator for the event. The competition was judged by Dr Radhika Dev Verma, Ms Simerjit Kaur, and Ms Imrose Tiwana. Participants were given a choice of various topics and were required to speak for one minute on their chosen topic. After the competition, Dr Radhika Dev Verma interacted with attendees and discussed World Heart Day, and an organizer gave an informative speech. The motive of this event was to make people aware of heart problems and how to cure them.

## 1. RECOGNISING SEX WORK AS A PROFESSION.

**Case Name-** *Budhadev Karmaskar v. State of West Bengal* 2022 SC 704

**Bench- Justices** *L. Nageswara Rao, B.R. Gavaia and A.S. Bopanna*

"Notwithstanding the profession, every individual in this country has a right to a dignified life under Article 21" Bringing relief to sex workers, the Supreme Court directed the Unique Identification Authority of India to issue AADHAAR cards to the sex workers. The court said, "Notwithstanding the profession, every individual in this country has a right to dignified life under Article 21 (Right to Life) of the Constitution." The apex court also ordered police forces throughout the country to treat sex workers and their grievances with respect and dignity.

## 2. UPHOLDING VALIDITY OF THE 103RD CONSTITUTIONAL AMENDMENT

**Case Name-** *Janhit Abhiyan v. Union of India* 2022 SC 1540

Bench- Former Chief Justice UU Lalit and Justices Dinesh Maheshwari, S Ravindra Bhat, Bela M Trivedi and JB Pardiwala. "Reservation is not an end but a means – a means to secure social and economic justice" The Supreme Court granted relief to economically weaker sections and upheld 10% reservation despite it crossing the 50% ceiling of total reservations in the country as per guidelines by the top court.

## 3. GRANTING THE RIGHT TO ABORTION TO UNMARRIED WOMEN

**Case Name-** *Xv. Principal Secretary, Health and Family Welfare, Govt of NCT Delhi* 2022 SC 1321

**Bench- Justices** *DY Chandrachud, Surya Kant and AS Bopanna*

Paving the way to empowering single women, the Supreme Court allowed unmarried women a choice to terminate their pregnancy upto 24 weeks. The court delivered an important interpretation of Rule 3B (Women eligible for termination of pregnancy up to twenty-four weeks) of the Medical Termination of Pregnancy Rules, 2003. The court has said, "The meaning of rape must include the meaning of marital rape solely within the meaning of the MTP Act and Rules. Such a requirement of proving rape for the purpose of the MTP Act shall be against the object of the Act."

## 4. PROHIBITING THE "TWO-FINGER TEST" IN RAPE CASES

**Case Name-** *State of Jharkhand v. Shailendra Kumar Rai*, 2022 SC 1494

**Bench- Justices** *DY Chandrachud and Hima Kohli*

Bench- Justices DY Chandrachud and Hima Kohli "The two-finger test has no scientific basis. It instead re-victimises and re-traumatizes women." The Supreme Court in this verdict held that any person who conducts the 'two-finger' test on sexual assault survivors. shall be held guilty of misconduct. A Bench comprising Justices DY. Chandrachud and Hima Kohli said that the reason behind using this "regressive" test on traumatised sexual assault survivors was to ascertain whether the woman or girl was "habituated" to sexual intercourse. The Court thus held that such a "concern" was irrelevant to whether she was raped or not. "This so-called test has no scientific basis and neither proves nor disproves allegations of rape. It instead re-victimises and re-traumatizes women who may have been sexually assaulted and is an affront to



their dignity. The 'two-finger' test or pre-vaginum test must not be conducted," the judgment directed. The Bench noted that the Ministry of Health and Family Welfare had issued guidelines for health providers in cases of sexual violence, and directed that these guidelines be followed to the letter.

## 5. SPLIT DECISION IN HIJAB BAN CASE

Case Name- Aishat Sifha v. State of Karnataka, (2023) 2 SCC 1

Bench- Justices Hemant Gupta and Sudhanshu Dhulia "The High Court took a wrong path. It is ultimately a matter of choice and Article 19(1)(a) and 25(1). It is a matter of choice, nothing more and nothing less," - Justice Sudhanshu Dhulia On the crucial issue of hijabs in the schools of Karnataka, two judges of the Supreme Court delivered a split judgment. Justice Hemant Gupta upheld the Karnataka High Court's order denying women their right from wearing the hijab in educational institutions. Justice Dhulia however ruled a Muslim girl's decision to wear the hijab is her own and cannot be subject to any limitations.

## 6. KEEPING SEDITION LAW ON HOLD

Case Name- S.G. Vombatkere v. Union of India (2022) 7 SCC 433 Bench- Former Chief Justice NV Ramana and Justices Surya Kant and Hima Kohli "Section 124A of IPC is not in tune with the current social milieu, and was intended for a time when this country was under the colonial regime."

## 7. NO INDIVIDUAL CAN BE FORCED TO RECEIVE COVID VACCINATIONS

Case Name- Jacob Puliyel v. Union of India 2022 SCC OnLine SC 533 Bench- Justices L Nageswara Rao and BR Gavai "Bodily integrity is protected under Article 21 of the Constitution of India and no individual can be forced to be vaccinated." The Supreme Court said no one could be forced to receive COVID-19 vaccinations under Article 21 (Protection of Life and personal liberty) of the Constitution of India. The court noted a person's right to bodily integrity includes the freedom to refuse vaccinations.

## 8. DAUGHTER'S RIGHT TO INHERIT SELF-ACQUIRED PROPERTY

Arunachala Gounder v. Ponnusamy (2022) 11 SCC 520 Bench- Justices S Abdul Nazeer and Krishna Murari "The legislative intent of enacting Section 14(l) of the Act was to remedy the limitation of a Hindu woman who could not claim an absolute interest in the properties inherited by her but only had a life interest in the estate so inherited." In a landmark judgment, the Supreme Court said a Hindu daughter has the right to inherit self-acquired property or portion obtained in the division of a coparcenary property of her Hindu father dying intestate. The Court stated that this principle is recognised not only in customary Hindu law but also through various judicial pronouncements of this court.

## 9. APEX COURT UPHELD THE VALIDITY OF VAST POWERS CONFERRED TO ED UNDER THE PREVENTION OF MONEY LAUNDERING ACT

Case Name- Vijay Madanlal Choudhary v. Union of India 2022 SCC OnLine SC 929 Bench- Justices AM Khanwilkar, Dinesh Maheshwari and CT Ravikumar "Money Laundering is one of the heinous crimes, which not only affects the social and economic fabric of the nation but also tends to promote other heinous offences, such as terrorism, offences related to NDPS Act, etc."

## 10. NEIL AURELIO NUNES & ORS. VS UNION OF INDIA & ORS. (2022) 4 SCC 1

"Merit cannot be reduced to narrow definitions of performance in an open competitive examination which only provides formal equality of opportunity", the Supreme Court held and allowed 27% reservation for Other Backward Classes for the NEET-AIQ entrance exam.



## **11. HOTEL PRIYA A PROPRIETORSHIP VS STATE OF MAHARASHTRA 2022 SCC ONLINE SC 204**

The Supreme Court lifted restrictions imposed on the number of women who can perform at orchestra, bars in Maharashtra. The apex court observed that the number of performers cannot be limited as it will affect their ability to make a choice under the guise of protection. "Practices or rules or norms are rooted in historical prejudice, gender stereotypes and paternalism have no place in our society."

## **12. MONIRUL MOLLA VS THE STATE OF WEST BENGAL 2022 SCC ONLINE CAL 675**

The Calcutta High Court in this judgement issued an order to trial courts in West Bengal mandating that only rape crimes might result in a sentence of life imprisonment to death, without the option of remission. It also added that only the High Courts and the Supreme Court had the authority to issue such life sentences without granting remission.

## **13. GUJARAT GOVT VS CISF 2022 SCC ONLINE SC 1734**

The Supreme Court said, "Police officers are not required to do moral policing," and upheld the Gujarat High Court's dismissal of the Central Industrial Security Force (CISF) officer who harassed a young couple at night.

## **14. DELHI AIRPORT METRO EXPRESS PVT. LTD. V. DELHI METRO RAIL CORPORATION CIVIL APPEAL NO. 5627 OF 2021 SC**

This recent case was concerned with Section 31(7)(a) Arbitration and Conciliation Act, 1996 i.e. Power of the arbitral tribunal to award interest if parties are subject to an agreement on the same. In this case, the issue which was raised was Can an arbitral tribunal award interest if the parties have agreed otherwise? In answer to this the Supreme Court held that when the parties have an agreement between themselves that governs the issue of interest, the arbitrator would lose its discretion and will be guided by the agreement between the parties.

## **15. PSYCHIATRIC EVALUATION IS NEEDED BEFORE IMPOSING THE DEATH PENALTY**

Case: In *Manoj vs State* (2023) 2 SCC 353, the Supreme Court laid down guidelines and steps, including psychiatric evaluation, that should be considered before imposing the death penalty. Facts: In this case, Manoj Pratap Singh was convicted of raping and killing an 8-year-old disabled girl in Rajasthan. Singh committed the crime in 2013 when he was 28 years old. His victim was both mentally and physically challenged. What Supreme Court said: The court said that conducting this form of psychiatric and psychological evaluation will provide a baseline for the courts to use for comparison and to evaluate the progress of the accused towards reformation achieved during the incarceration period.

# BILLS MONSOON SESSION 2022

---

- The Family Courts (Amendment) Bill, 2022 seeks to amend the parent Act to provide for the establishment of Family Courts in the State of Himachal Pradesh with effect from the 15th February 2019 and in the State of Nagaland with effect from the 12th of September, 2008; and for insertion of a new section 3A to retrospectively validate all actions under the parent Act taken by the State Governments of Himachal Pradesh and Nagaland.
- The Weapons of Mass Destruction and their Delivery Systems (Prohibition of Unlawful Activities) Amendment Bill, 2022, inter alia, seeks to — (a) prohibit financing of any activity in relation to weapons of mass destruction and their delivery systems; (b) empower the Central Government to— (i) freeze, seize or attach funds or other financial assets or economic resources for preventing such financing; (ii) prohibit making available funds, financial assets or economic resources for any prohibited activity in relation to weapons of mass destruction and their delivery systems.
- The Indian Antarctica Bill, 2022 provides for the national measures for protecting the Antarctic environment and dependent and associated ecosystems and to give effect to the Antarctic Treaty, the Convention on the Conservation of Antarctic Marine Living Resources and the Protocol on Environmental Protection to the Antarctic Treaty and for matters connected therewith or incidental thereto.
- The National Anti-Doping Bill, 2021 provides for the constitution of the National Anti-Doping Agency for regulating anti-doping activities in sports and to give effect to the United Nations Educational, Scientific and Cultural Organisation International Convention against doping in sport, and compliance of such other obligations and commitments thereunder and for matters connected therewith or incidental thereto.
- The Central Universities (Amendment) Bill, 2022 seeks to amend the Central Universities Act, 2009, inter alia, to provide for the establishment of Gati Shakti Vishwavidyalaya as a body corporate.

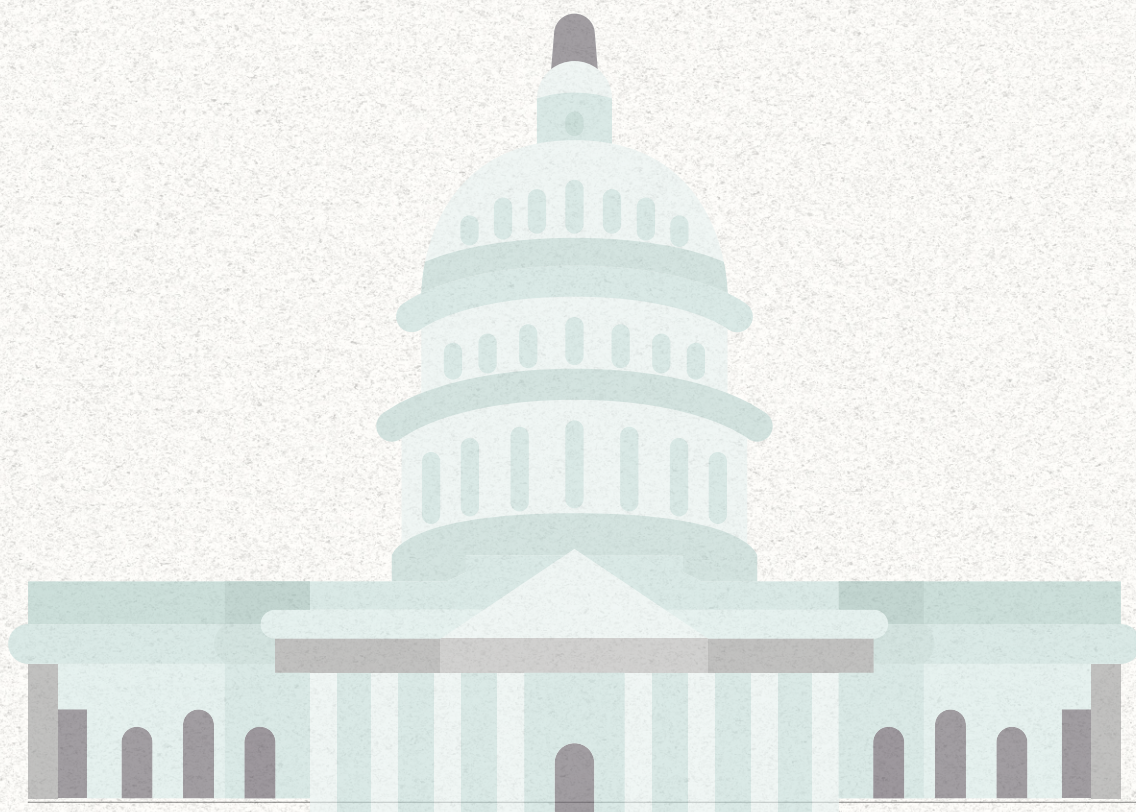




# GOVT SCHEMES

---

- **Pradhan Mantri Jan Dhan Yojana:** Pradhan Mantri Jan Dhan Yojana is a National Mission on Financial Inclusion that provides an integrated approach to bring about robust financial inclusion and ultimately provide banking services to all households in the country.
- **Make in India:** PM Narendra Modi launched the 'Make in India' campaign that will facilitate investment, foster innovation, enhance protection for intellectual property and build the best in manufacturing infrastructure. 'Make in India' has identified 25 sectors in manufacturing, infrastructure and service activities and detailed information is being shared through interactive web-portal and professionally developed brochures.
- **Swachh Bharat Mission:** Swachh Bharat Mission was launched in the entire country as a national movement. The campaign aims to achieve the vision of a 'Clean India' by 2nd October 2019. The Swachh Bharat Abhiyan is the most significant campaign with regard to sanitation by the Government of India.
- **Beti Bachao Beti Padhao:** The goal of this scheme is to make girls socially and financially self-reliant through education.
- **Atal Pension Yojna:** Atal Pension Yojana is a pension scheme mainly aimed at providing a universal pension scheme for those who are a part of the unorganized sector such as maids, gardeners, delivery boys, etc.
- **Digital India Mission:** The Digital India programme is a flagship programme of the Government of India with a vision to transform India into a digitally empowered society and knowledge economy.
- **Pradhan Mantri Shram Yogi Maan-dhan:** The PM-SYM is a contributory pension scheme that provides a minimum assured pension of Rs 3000 per month to subscribers above 60 years of age. The scheme also offers a family pension to the spouse and a continuation of the scheme for the spouse in case of the subscriber's death before the age of 60.
- **Gold Monetisation Scheme:** Gold Monetisation Scheme was launched by the Government of India in 2015, under this scheme one can deposit their gold in any form in a GMS account to earn interest as the price of the gold metal goes up.
- **PM CARES Fund -Prime Minister's Citizen Assistance and Relief in Emergency Situation Fund:** This is a public charitable trust initiated by Prime Minister Narendra Modi. This national trust is created with the objective to meet the distressed and dreadful situations like COVID-19 in the times ahead. PM CARES was initiated on March 28, 2020, under the chairmanship of the Indian Prime Minister with the Ministry of Home Affairs, Defence Minister and Finance Minister as the ex-officio Trustee.





# GOVT SCHEMES

---

- **Aarogya Setu:** The Government of India took the initiative to fight the Coronavirus pandemic. It launched a mobile application to spread awareness of COVID-19 among the citizens of India through an app called Aarogya Setu. The Aarogya Setu mobile app has been developed by the National Informatics Centre (NIC) that comes under the Ministry of Electronics and Information Technology.
- **Ayushman Bharat:** Launched in 2018 by Prime Minister Narendra Modi Ayushman Bharat is a health scheme. It is the largest government-funded healthcare programme in the world with over 50 crore beneficiaries. The Ayushman Bharath programme has two submissions PM-JAY & HWCs.
- **Pradhan Mantri Jan Arogya Yojana (PM-JAY),** earlier known as the National Health Protection Scheme (NHPS) will cover the financial protection for availing healthcare services at the secondary and tertiary levels.
- **UMANG – Unified Mobile Application for New-age Governance** is a mobile application launched by PM Narendra Modi to provide secured access to the citizens to multiple government services on one platform. UMANG is a key component of the Digital India government initiative
- **PRASAD Scheme – Pilgrimage Rejuvenation And Spirituality Augmentation Drive.** The Scheme was launched under the Ministry of Tourism in the year 2015. The aim of the PRASAD Scheme is the integrated development of pilgrimage destinations in a prioritized, planned, and sustainable manner for providing a complete religious tourism experience.
- **Atmanirbhar Bharat Abhiyan –** The scheme (meaning self-reliant India scheme) is a name given to the full-fledged economic stimulus package announced by the Union Government. It has been launched with the aim to make people self-dependent and overcome the difficulties caused by the coronavirus pandemic.
- **National Digital Health Mission –** Launched on August 15, 2020, the mission aims to create an integrated healthcare system linking practitioners with patients digitally by giving them access to real-time health records.
- **PM Atmanirbhar Swasth Bharat Yojana –** The scheme is launched to develop capacities of primary, secondary, and tertiary health care systems, strengthen existing national institutions, and create new institutions, to cater to the detection and cure of new and emerging diseases.
- **National Infrastructure Pipeline Project –** It is a social and economic infrastructure project which was launched in 2019 in order to improve the overall quality of life for all citizens. The NIP will fulfil all the crucial factors that will help India in achieving its target of becoming a \$5 trillion economy by the financial year 2025.

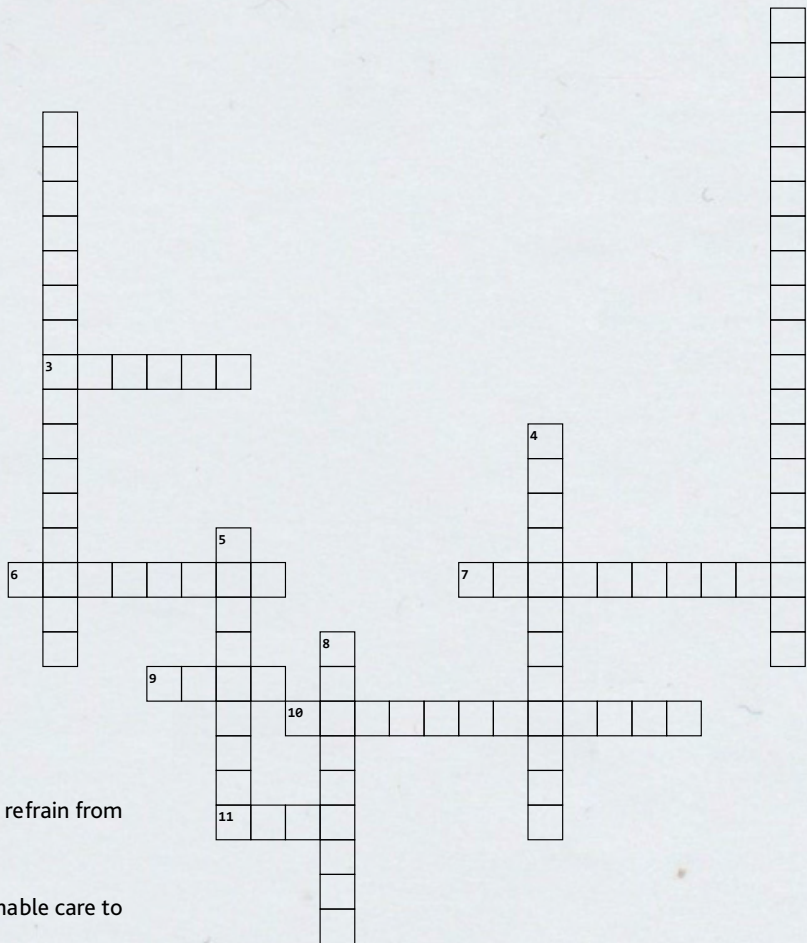

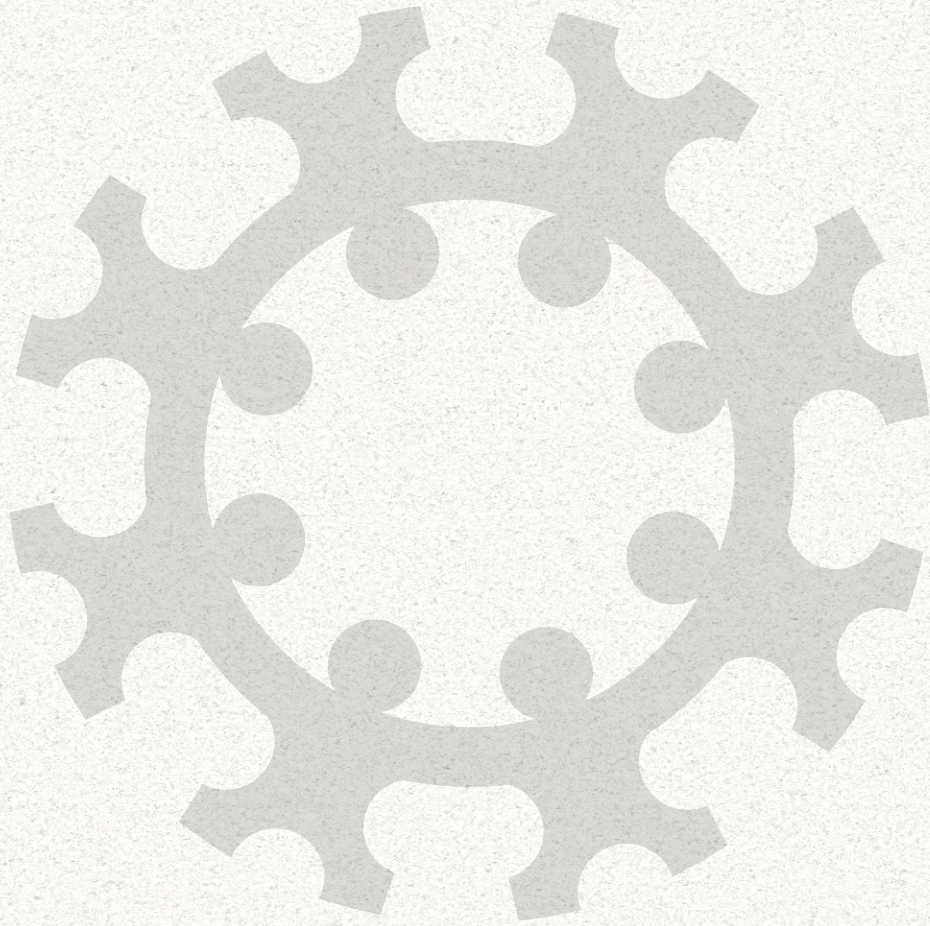
